IN 2017, THE SERIES ATTENDANCE WAS OVER 14,000. PREMIER CONCERTS PRESENTED A CONCERT FEATURING THE VERY POPULAR TEDESCHI TRUCK BAND WHICH DREW AN ATTENDANCE OF 8,000. OTHER EVENTS INCLUDED A FLEA MARKET -SMORGASBORD EVENT IN THE SPRING AND A CHILI-FEST-SPOOKTACULAR EVENT IN THE FALL THAT EACH DREW 3,000 PEOPLE. IN AUGUST, TWO LEFT FEET PRESENTED A THREE DAY BLUESFEST.
